

CWL Champs Trip Giveaway

Official Rules

No Purchase Necessary to Enter or Win. A Purchase will Not Increase Your Chances of Winning.

Eligibility: The CWL Champs Trip Giveaway (hereafter, "Sweepstakes") is open to legal residents of the 48 contiguous United States and District of Columbia (excluding Alaska, Hawaii, Puerto Rico and other U.S. territories and possessions), who are 18 years of age or older (except residents of Alabama and Nebraska, who must be 19 years of age or older and residents of Mississippi, who must be 21 years of age or older) as of date of entry. Employees, officers, directors, agents and representatives of Major League Gaming Corp. ("Sponsor"), Wishpond Technologies Ltd. ("Developer"), teamDigital Promotions, Inc. Proof of submission is not proof of receipt. **Limit one (1) entry per person and per household throughout the Promotion Period. You may only use one (1) email address to enter the Sweepstakes. Entries received from any person, email address, or household in excess of the above stated limitation will be void.**

Your submission of an entry constitutes your consent to participate in this Sweepstakes and your consent for Sponsor to obtain, use and transfer your name, address and other information for the purpose of administering this Sweepstakes. Winner Selection: One (1) potential winner will be selected in a random drawing conducted on or about 8/5/19 from among all the eligible entries received by Developer during the Promotion Period. By entering, entrants agree to be bound by these Official Rules and to the decisions of the Sponsor, which will be final and binding in all respects. Potential winner will be notified by Administrator at the telephone number provided in their entry. The first randomly selected potential Grand Prize winner that answers a telephone call placed by Administrator notifying him/her of his/her potential winning status and who agrees to accept such prize and completes and returns their Affidavit of Eligibility, Liability and (where legal) Publicity Release (as noted below) will be declared the Grand Prize winner, subject to verification of eligibility and the terms of these Official Rules. Messages will not be left on answering machines or with live persons and if an individual declines prize or is not available for any reason when called, his/her prize opportunity will be forfeited and, at Sponsor's discretion, an alternate winner will be selected. Prize: (1) Grand Prize: A 3-day/2-night trip for winner and one (1) guest to Los Angeles, CA to attend the 2019 Call of Duty World League Championship (the "Event").
