

Community Tournaments Frequently Asked Questions

I want to put on a Call of Duty® tournament. What is the first step?

You're on the right track. All Call of Duty® tournaments need prior approval and a license. The first step in the process is to complete a request form for review. If approved, we will provide a tournament license that will require a signature for the specific event you'd like to run. As a note, this does not give you exclusivity to run tournaments as each tournament requires a license.

When should I submit an event request form?

We ask that all requests be submitted no later than 2 weeks prior to the first event date. Event requests submitted with less than 2 weeks notice will be moved to a later date. The earlier the submission, the better.

Is there an age restriction for participants?

Yes. All participants MUST be 18 years and older to compete in any Call of Duty® tournament. No exceptions.

What are some prizing considerations?

All prizing requires review and approval. Acceptable prizes include but are not limited to merchandise, gift cards, and cash.

- If providing cash prizing, all pools must be fixed. Prizing must be set in advance of the tournament start date and cannot be determined by the number of teams/participants who enter. For example, if a tournament had a prize pool of \$10,000 and was expected to have 16 teams participate but only end up with 12 teams entering, prizing would still need to remain at \$10,000.
- Total cash (or cash value) of your prize pool for a single day tournament cannot exceed \$50,000 USD.

Am I allowed to have entry fees for my tournament?

All entry fee requests require additional review and approval. As a note, fees must be allocated solely to help offset costs in organizing your tournament and cannot contribute to the prize pool.

All WARZONE tournaments must be FREE ENTRY to participants.

Am I allowed to bring in sponsors?

Yes. Please note that all event sponsors must be approved by Activision.

- No sponsors or associations are permitted in any of these prohibited categories:
 - Non-Activision Blizzard games or related exploitations
 - Drugs (legal or illegal) or any products used to consume drugs including cannabis
 - Tobacco and any products used to consume tobacco
 - Pornography, sexual or adult-oriented products or services
 - Gambling (legal or illegal)
 - Firearms and weapons
 - Political candidates or ballot initiatives
 - Religious products or services
 - Cryptocurrencies and Cryptocurrency exchanges
 - Alcohol (e.g., beer, wine, cider, and other malt-based beverages)
 - Illegal goods and services

Can I do a LAN event?

Activision will consider live event requests (in-person/LAN) on a case-by-case basis. Any approved requests for in-person/LAN events must comply with local laws relating to COVID-19 safety, including health screening and adequate security measures as may be more fully set forth in the Activision Tournament License Agreement or your event agreement.
